This year marks a special milestone for Buffalo Conrail Federal Credit Union. Our charter was granted on December 12, 1935, and we officially opened our doors on January 13, 1936, beginning a legacy of service that has now lasted nine decades.

What started with sixteen founding members at the Buffalo Central Terminal has grown into a strong, member-centered financial cooperative serving railroad families, retirees, SEG groups, and extended families across Western New York.

Through changing times, industries, and generations, one thing has remained constant: our commitment to providing fair, dependable, people-first financial service.

Our History

Buffalo Conrail Federal Credit Union was born from the Federal Credit Union Act of 1934, which expanded financial access to working Americans. Inspired by the opportunity, Thomas A. Mahoney and fellow New York Central Railroad employees formed what became Charter No. 845 in 1935.

The credit union originally operated from the historic Buffalo Central Terminal. Over time, our name evolved with the railroad industry—from New York Central System Employees Buffalo FCU, to Buffalo Penn Central FCU, and now Buffalo Conrail FCU. Today, we continue our founding mission: to serve members of modest means through cooperative, trustworthy, member-owned banking.

Nominations by Petition

Members may also be nominated by petition. To be valid, each petition must:

- Be signed by 1% of the membership (minimum 20 signatures, maximum 500)
- Include a signed certificate from the nominee agreeing to serve
- Include a biographical statement
- Be submitted to the Secretary no later than February 7, 2026

All nominations will be posted at the credit union at least 35 days before the Annual Meeting.

Election Procedures

If the number of nominees equals the number of open positions, the election will not be conducted by ballot. There will be no nominations from the floor. In this case, nominees will be elected by general consent at the Annual Meeting. If more candidates are nominated than positions available, a ballot election will be held.
